As background, captives have been used by large firms and industry groups for self-insurance of the best risk companies with phenomenal savings along with investment benefits. In the private sector, captives also exist and the key is to have a trusted, very capable advisor to evaluate and administer the process to apply to a captive and then manage the relationships. The relevant insurance coverages include workmen's comp, general liability and often fleet coverage.

From a CFO standpoint, we learned, and you can review on the zoom recording on our website if you missed the session, that this clearly is a best practice, not available to everyone that encompasses a culture change, creates a very long term approach to managing risk coupled with a financial structure with incredible benefits. Also, captives of 30 years ago were crude and had some problems so don't let a past perception or problem taint your review of what a current captive can do for you.

My engineering firm is in NYC and an expensive insurance market. We have had a perfect record in work comp, general liability and fleet in the last two years-wish I would have met John 3 years ago!

If your premiums for the above coverages exceed \$200k AND you are a safety conscious, above average risk firm, you should schedule some time with John. If you don't know where you stand on near misses, recordables, claims, loss management-you need an insurance advisor and

not an insurance broker/ sale-person! For example, if you ,as CFO, are not analyzing risk, driving the appropriate analysis and reporting and actively managing the cost, your successor will likely do a better job. RISK management is a pillar of the financial executive's responsibility. If this is foreign to you, give me a call as we have covered this topic before and we have many best practices to help you.
